



# Privacy Policy

At People For Nature, we are committed to protecting your privacy. This Privacy Policy explains how we collect, use, and safeguard your personal information when you interact with our website and services. By using our website or services, you agree to the terms outlined in this policy.

## What is Personal Information?

Personal information is information or an opinion about an identified individual, or an individual who is reasonably identifiable whether the information or opinion is true or not, and whether the information is recorded in a material form or not.

## Information we Collect

We may collect personal information in the following ways:

- Personal Information: When you donate, sign up for workshops or programs, subscribe to our newsletter, or contact us, we may collect personal details such as your name, email address, phone number, and payment information.
- Non-Personal Information: We may collect non-personal information such as your IP address, browser type, and device information to improve the functionality and performance of our website.

## How We Use Your Information

We use the information we collect to:

- Process donations and event registrations.
- Communicate with you regarding your involvement with People For Nature, such as updates on campaigns, events, and newsletters.
- Maintain an up-to-date volunteer register to ensure compliance with insurance requirements.
- Improve our website and services.
- Respond to inquiries and support requests.



## **How We Protect Your Information**

We implement security measures to protect your personal information. However, please be aware that no method of data transmission over the internet or method of electronic storage is completely secure, and we cannot guarantee absolute security.

We have strict contractual arrangements in place with the service providers, external agencies, staff and volunteers with whom we may share your personal information. Contractual arrangements with companies who provide services on our behalf, including any companies based overseas, are prepared in accordance with the Privacy Act 1988 (Cth) and the Australian Privacy Principles.

As required, we also enter into data processing agreements with these companies that respond to stricter privacy conditions that may be in place from time to time (e.g. the European Union's General Data Protection Regulation). From time to time, we also undertake internal reviews of our data collection, storage and processing practices and security measures, as well as physical security measures to guard against unauthorised access to systems where we store personal information.

Personal information is held only for as long as the personal information remains relevant to the purpose for which it was collected.

## **Anonymity and Pseudonymity**

When it is not impracticable or unlawful, you are welcome to interact with us without identifying yourself, or by using a pseudonym. For example, donations to us can be made anonymously, and we will not disclose the details of that donation unless required by law.

## **Cookies and Tracking Technologies**

Our website may use cookies and similar technologies to enhance your experience, analyse website traffic, and personalise content. You can set your browser to refuse cookies, but doing so may limit certain features on our website.



## Your Rights

You have the right to:

- Access the personal information we hold about you.
- Request corrections or updates to your personal information.
- Request the deletion of your personal information, subject to any legal obligations we may have.
- Opt-out of receiving communications from us at any time by following the unsubscribe instructions in our emails or contacting us directly.

## Children's Privacy

People For Nature does not knowingly collect or solicit personal information from children under the age of 13. If we learn that we have collected personal information from a child under 13 without verification of parental consent, we will delete that information as quickly as possible.
